The Government of the People's Republic of Bangladesh has received financing from the World Bank toward the cost of the Sustainable Coastal and Marine Fisheries Project (SCMFP), and intends to apply part of the proceeds toward payments under the contract for Supply of eight (8) Patrol Boats (Surveillance) for Marine Fisheries Surveillance Check (MFSC) Post.
2. The Department of Fisheries now invites sealed Bids from eligible Bidders for Supply of Patrol Boat for Marine Fisheries Surveillance Check Post (MFSC), located at coastal areas of Bangladesh (details in the Bid Document). Margin of Preference will be applicable. Delivery Period for supply of 8 Patrol Boats is 12 months.
Bidders are advised to refer to the bidding documents for further details, including Schedule of Requirements and the post qualification requirements.
3. Bidding will be conducted through international competitive procurement (one envelope bidding process) using a Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers" July 2016, Revised November 2017 ("Procurement Regulations"), and is open to all eligible Bidders as defined in the Procurement Regulations.
4. Interested eligible Bidders may obtain further information from Project Director, Sustainable Coastal and Marine Fisheries Project, Department of Fisheries, Matshya Bhaban, Dhaka, Bangladesh, E-mail: pdscmfpdof@fisheries.gov.bd and inspect the bidding document during office hours i.e. 0900 to 1700 hours ((Local time- GMT+06:00 Hours) at the address given below. The bidding document is also available in the **Notice** board of the websites of Department of Fisheries (www.fisheries.gov.bd) and scmfp.fisheries.gov.bd, which can be downloaded for viewing/inspection purpose only but not for use in the preparation and submission of bids.
5. A complete set of the bidding documents in English may be purchased by prospective bidders upon (i) submission of a written application letter which may be sent through email from the bidder's official email address to the Purchaser's official email address specified below and (ii) payment of a nonrefundable fee which includes courier services cost for delivery of the bidding documents to the bidder. The fee for bidding documents requested by bidders for delivery outside Bangladesh is USD100.00 or BDT8500.00. The fee for bidding documents requested by bidders for delivery within Bangladesh is BDT4500.00. The method of payment of the fee is through electronic wire transfer by the bidder to the Purchaser's bank account specified below. A copy of the electronic wire transmission confirmation must be attached, as evidence of payment, with the bidder's application letter. Within 3 (three) working days of receipt by the Purchaser of the bidder's email with the application letter and copy of the electronic wire transmission confirmation, the Purchaser will dispatch a complete set of the bidding documents to the bidder through courier service and also inform the bidder through email of the courier service order/tracking number. The Purchaser shall not be responsible or liable for any delay or failure of delivery of the bidding documents by the courier service to the bidder.
6. Bids must be delivered to the address below on or before 15:00 Hours (Local Bangladesh time- GMT+06:00Hours), 22 December 2020. Electronic Bidding will not be permitted. Late Bids will be rejected. Bids will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend at the address below on 15.30 Hours (Local Bangladesh time- GMT+06:00Hours), 22 December 2020. The bid opening meeting will also be conducted live through virtual connection for those bidders who may be unable to attend in person. The virtual connection details will be sent, not later than 7 (seven) calendar days before the specified deadline date of bid submission, to all the bidders who purchased the bidding documents.

7. All Bids must be accompanied by a Bid Security of USD 35000.00 or an equivalent amount in a freely convertible currency as per the requirements detailed in the bidding documents.
