- 1. The Contract agreement should be signed before import of the SPF Black Tiger Shrimp.
- 2. The Desh Bangla SPF Hatchery will submit a bank solvency certificate.
- 3. Pre import permission from the Department of Fisheries Bangladesh (the competent authority-CA) will be required for the import of SPF shrimp in future.
- 4. Pathogen (OIE listed) free certificate, before importation to be submitted from the competent authority of importing Country.
- 5. After importation, Quarantine and disease free certificate is to be confirmed by authorized lab/institution in Bangladesh followed by Fish Quarantine Act, 2018 and Fish Hatchery Rules, 2011.
- 6. The pre import permission is valid for a period of maximum 1 (one) year from the date of issue.
- 7. The hatchery should follow the SPF protocol approved by Ministry of Fisheries and Livestock.
- 8. SPF Black Tiger Shrimp (*Penaeus monodon*) should be imported from the country where there is no evidence of EMS cutbreak.
- 9. Skilled/trained manpower relevant to shrimp hatchery management should be in place.
- 10. The signed agreement will deem to be fit and proper for importation and operation of the said SPF hatchery so long the hatchery will operate and follow the terms and condition as stated in the agreement.
- 11. The Importers will assist in Quarantine activity along with the cost involved.
