Invitation for Expression of Interest

The Department of Fisheries (DoF) under the Ministry of Fisheries and Livestock is implementing the Sustainable Coastal and Marine Fisheries Project (SCMFP) with the financial assistance of the International Development Association (IDA Credit No.6326-BD) to develop the marine and coastal fisheries of Bangladesh. SCMFP has an allocation for MARICULTURE APPLIED/ACTION RESEARCH, TECHNOLOGY INNOVATION, COMMERCIALIZATION, AND PRODUCTION PILOTING. The objective of this allocation is to provide competitive research grants for (i) studies on contemporary high-priority blue economy issues such as climate change, and establishment of aqua-economic zones; and (ii) adaptive and/or action research that addresses coastal and marine fisheries development issues. Now, Sustainable Coastal and Marine Fisheries Project (SCMFP) is hereby inviting Expression of Interest (EOI) from interested and eligible public/private research and educational institutions and enterprises involved in the mariculture value chain in Bangladesh to undertake sub-projects on applied mariculture (technology innovation, market studies, and production piloting) and aquaculture research (piloting commercial opportunities such as mud crab and finfish hatcheries, freshwater shrimp, shrimp and crustacean feed, probiotics, and others as viable). Eligible areas also include cage culture, grow-out operation of mud crab, mussels, finfish, crustaceans, seaweeds, product development and value-added processing, and cold chains development etc. Proposals on improved varieties of fish/shellfish for culture, improved fingerling quality, more ecologically and economically efficient production technology, innovative disease management systems, and water quality monitoring systems will also be considered for funding under this window.



Terms and conditions:

1. Applicants must be registered and operating in Bangladesh (whether domestic or foreign-owned or a joint venture) in compliance with relevant business regulations in Bangladesh;
2. Research organizations should have a minimum of 10 years of experience in research with at least five years of experience in the area of the grant application.
3. Host organization must have adequate Human Resources and Research Facilities.
4. Principal Investigators (PIs) of the sub-project will have at least a Master's degree and journal publications in relevant fields and S/he will devote at least 30% time to the project.
5. Experience of outreach research activities for the commercialization of innovative technology will be preferred.
6. The applicant must demonstrate proven experience in conducting similar research and innovation.
7. All those above (Sl.no.4-6) will be endorsed by the head of respective organizations.
8. The sub-project must contribute to improved productivity and incomes, increased employment and create new economic opportunities across the seafood value chain, particularly for small-scale growers and creating

- opportunities for supplying international markets with seafood products (export-led growth).
9. The sub-project shall be relevant to the SCMFP geography and/or development area, and beneficiary groups.
 10. The Sub-projects must be technically feasible and supported by complete materials and methods.
 11. The sub-project must not create permanent unfair competition or otherwise distort markets.
 12. The project encourages the co-financing whereas a bank defaulter will not be considered as an eligible applicant.
 13. A for-profit (intending to generate a return for shareholders/members) private sector or joint venture enterprise that operates commercially and without government subsidy (business membership organisations and associations and NGOs are eligible to apply for funding provided they are in a consortium/partnership led by an eligible private or public-sector business);
 14. The sub-project must comply with World Bank Group social and environmental safeguards policies and the Project Environmental and Social Management Framework (ESMF), and must not cause any social or environmental damage.
 15. Sub-project built on encroached areas viz. river levees, accredited chars, planted or natural mangrove patches or in illegally occupying or having legal disputes will not be eligible for grant support.
 16. Measurable contributions to social development, such as effective gender mainstreaming, employment of ethnic communities and disabled people, proactive measures to develop research capacity and skills among youth and women, entrepreneurship development, and environmental sustainability will be given preferences.
 17. The beneficiary must complete the carrying out of the sub-project before the Closing Date for the Project.
 18. Department of Fisheries (DoF) shall reserve the copyright of research findings/intellectual properties from all the sub-projects carried out under this grant facilities.
 19. The EOI shall be submitted in a sealed envelope, inscribing "Application for MARICULTURE APPLIED/ACTION RESEARCH, TECHNOLOGY INNOVATION, COMMERCIALIZATION AND PRODUCTION PILOTING" to the Project Director, Sustainable Coastal and Marine Fisheries Project (SCMFP), Room no. 1011 (10th Floor), Matshya Bhaban, Ramna, Dhaka-1000" on or before 27 March 2023, 12.00 PM. The applicant shall submit a soft copy of the EOI through email (pdscmfpdof@fisheries.gov.bd, azam_dof@yahoo.com) and/or digital copy in pen drive.
 20. The offer for EOI as per this document shall be valid for a period of One Hundred and twenty days (120) initially which may be extended further if required by authority.
